Citizens (or the subject of that personal data) have new rights to see, correct, amend or demand removal of any data that organisations hold. This results in the need for programme that:

Reviews personal data held to ensure that it is accurate. Any inaccurate data will need to be erased or corrected; Reviews internal policies and audit procedures, updating these where necessary to ensure that the procedures comply with the GDPR;

Maintain documentation relating to how data is processed to ensure that the organisation has evidence that it is fulfilling its duties under the GDPR;

Ensure that appropriate training is provided to ensure that the business is thinking about data protection issues at all levels;

Consider approved codes of conduct and certification mechanisms which are to be designed by industry or sector specific bodies.
